evaporation.

Engineers to do the dredging, 2: A friend of hers mentioned that in the

50's-60's there was a pipe on Eagle Ranch that ran from the

ranch and ends close to the lake. Perhaps it could be used again? Don

Lynge will follow up.

- Don Lynge said that
 - the city is still waiting for clearance from the Regional Water Quality

Control Board to sell the dredged soil.

Barbara Combs

attended the city council meeting the night they voted to put the extra

sales tax for road and infrastructure on the November ballot. The wording includes "other vital needs". There could be a possibility in the

future to use a small portion of this tax for the lake. It was also suggested to get on the local radio shows to promote our group with a slogan

of "Put the "Lake" back into Atascadero Lake Park". It was also suggested to

write a letter of thanks to all who helped in relocating the geese and get

it into local papers. (this has been done).

• Sid Abma suggested

we get in touch with PG&E and talk with them about putting solar panels

on the Pavilion roof to provide power to run the fountains.

• It was also

suggested to write letters to Katcho Achadjian: <u>Assemblymember.Achadjian@assembly.ca.gov</u> and Lois Capps (you will have to e-mail her through her website) to help fast track dredging permits and grants for the lake.
